

## Voyageur Men Hockey League

Agreement between: \_\_\_\_\_  
and Voyageur Men Hockey League..

Regarding: Men's ice hockey winter season 2010-2011

I/we \_\_\_\_\_ hockey team/club, hereby contracts with Voyageur Men Hockey League, and in so doing, signify my/our commitment to enter a team in the aforementioned League by signing this form and providing (1) a non refundable deposit of six hundred dollars (\$1,000.00), along with the post dated cheques and bond noted below, the fully completed **team information form, roster list form**, and this signed **agreement**. Deposit and post-dated cheques will be returned in full if team rejected.

This application is based on the following terms and conditions:

- **All teams will play up to 24 games, including playoff**, between end of September 2010 and mid-April 2011.
- The team entry fee for the winter season 2010-2011, is \$5,160.00. The team must submit the initial deposit immediately along with post dated cheques/payments as follows:

1.	\$1,000.00	deposit immediately
2.	\$1,386.67	October 1 <sup>st</sup> , 2010
3.	\$1,386.67	November 1st, 2010
4.	\$1,386.66	December 1st, 2010

**Plus first year team must include separate \$150.00 cheque, dated October 1st, 2010 to cover returnable team bond for the season.**

- I agree to include with my application a cheque of \$150.00 dated October 1st, 2010 to cover **\$150.00 returnable team bond**. This bond will be applied towards any fines or charges (i.e. cancelled cheques/NSF cheques, sweaters rentals, property damages, penalty fines, etc) our team may be assessed. Should this bond reduced below, \$75.00, the reduced balance must be immediately replaced. Balance of team bonds will be held and carried over by the league until next season, unless the team indicates it will not be returning.
- I further agree to submit my player roster with this application for player approval by the league. Any and all new players wishing to play on this team may at any time requested by the League to provide picture I.D. and, at the League's discretion, any player may be denied entry to the League. The league reserves the right to prevent a player from joining the League after the League re-alignment date, whereby maintaining a balanced league will be the main criteria for refusal or acceptance.
- All cancelled cheques will cost the team a service charge of \$50.00, to be taken from the team bond.
- Any regularly scheduled and/ or playoff games that cannot be played at scheduled date and time due to arena commitments to other clients and/ or unforeseen problems will be re-scheduled at another time, and possibly another location.

- SWEATERS: Teams must have 2 sets of sweaters. All players on the same team MUST wear IDENTICAL sweaters (only exceptions are in logo or printing on player's sweaters, or the goaltender who may wear a predominately same color sweater). A minimum of \$10.00 per infraction will be applied and the game may go on at the discretion of League officials. Players not having proper sweater may rent one from the League if available, at \$8.00/ game.
- A player amassing a total of 50 minutes in penalties will be fined \$5.00 for any and all additional minors and \$10.00 for any and all additional majors and/ or misconducts, to be taken from the team bond.
- HELMETS: All helmets and goalie masks must be CSA approved with NO missing/ broken parts, and must have proper chin straps (no tape). NO EXCEPTIONS UNDER ANY CIRCUMSTANCES. If a player is seen on the ice with a non-conforming helmet or mask, he will receive an 'illegal equipment' minor penalty and will not be permitted to return to the ice until it is corrected or replaced. Helmet violations will also be called when a timekeeper or supervisor has informed referees.
- Final acceptance of a team into the League will be at the discretion of the League Officials and / or Voyageur Men Hockey League management.
- I / we agree that our team or any player on our team may be ejected from this League for **just cause** (i.e. displaying continual lack of respect or unacceptable aggression toward opposing players, referees, or League officials, intent to injure, ect...), without re-imbusement of League fees to that point. In case of a player ejection, I/ we agree that no re-imbusement of any kind will be made by the League. In case of a team ejection, the league reserves the right to retain the entire balance of the team entry, or minimally, a pro-rated equivalent of an additional four games from the time of ejection.
- If a shortage or cancellation of hours available to the Voyageur Men Hockey League results in insufficient hours to complete the full schedule, the Voyageur Men Hockey League reserves the right to reduce the number of games played by each team, and so adjust and reduce the team's entry fee for the season. For example, if the schedule is reduce to 23 games for the season 2010-2011 winter seasons; the team entry will be reduced to reflect a reduction in the schedule.
- My/ our signature here under on this AGREEMENT, accompanied by my/ our initial deposit cheque of \$1,000.00 payable to Voyageur Men Hockey League, as well as the 3 additional post-dated cheques totaling \$5,160.00 covering the balance of the entry fee, our completed **team information form**; our completed **roster list**; our **\$150.00 cheque for the team bond**, signifies my/ our commitment to enter my/ our team into the Voyageur Men Hockey League, subject to the men's League acceptance.
- I have read and understand this application and agree to inform all my team's players of all conditions contained there in as well as the league's Rules and Regulations.
